RESOLUTION NO. 159-93

A RESOLUTION STRONGLY OPPOSING THE INCREASE OF TEN PESOS (₱10.00) IN THE PASSENGER FARE BEING PROPOSED BY VIVA SHIPPING LINES AND STO. DOMINGO SHIPPING LINES ON THEIR VESSELS PLYING THE CALAPAN-BATANGAS/BATANGAS-CALAPAN SEA ROUTE.

WHEREAS, this Honorable Body has taken cognizance of a reliable information that the Viva Shipping Lines and the Sto. Domingo Shipping Lines have made representations with the Maritime Industry Authority (MARINA) for an increase of TEN PESOS (₱10.00) in the passenger fare for their vessels plying the Calapan-Batangas Batangas-Calapan Sea Route;

WHEREAS, the apparent justification for such as increase are the expected expenses which the shipping lines shall incur as a result of the improvement of their facilities, system and services for the comfort and convenience of the riding public;

WHEREAS, the envisioned improvement of the shipping lines' facilities system and services, aside from being the result of an agreement forged between them and the Provincial Government of Oriental Mindoro is an obligation these shipping are bound to provide the riding public, as holders of Certificates of Public Convenience;

WHEREAS, there have been series of passenger fare increases in the past but the public was never afforded the proportionate and reasonable comfort and convenience it justly deserves, on the contrary, experiences have proven that the lowly passengers are being harassed, abused and maltreated by the personnel of these shipping lines;

WHEREAS, their present services are still very far to be reasonably worth the passenger rate currently being imposed by these shipping lines;


WHEREAS, the approval of the proposed increase in the passenger rate shall work to the detriment and prejudice of the riding public because it would mean a continuing oppression and an insult to an already painful injury.

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved to oppose as it is hereby strongly opposing the increase of TEN PESOS (₱10.00) in the passenger fare being proposed by Viva Shipping Lines and Sto. Domingo Shipping Lines on their vessels plying the Calapan-Batangas/Batangas-Calapan Sea Route.


RESOLVED FURTHER, that the Maritime Industry Authority (MARINA) thru its Administrator, Honorable Paciencia M. Balbon, be furnished copies of this resolution for its information and favorable action.
