**RESOLUTION 228 - 93**

REQUESTING THE MARITIME INDUSTRY AUTHORITY (MARINA) TO INVESTIGATE AND TAKE APPROPRIATE ACTION ON THE CONTINUED IMPOSITION BY VIVA SHIPPING LINES AND STO. DOMINGO SHIPPING LINES IN THE BATANGAS-CALAPAN ROUTE OF THE 100% PENALTY ON UNTICKETED PASSENGERS UNDER MEMORANDUM CIRCULAR NO. 48 NOTWITHSTANDING THE DECISION OF THE MARINA BOARD DURING ITS 67TH BOARD MEETING SUSPENDING THE SAME.

WHEREAS, "during the 67th Board Meeting (held last 27 September 1993) the MARINA Board upon recommendation of Management approved the suspension of items Nos. (3) and (4) of MARINA MC 48 in view of the rising number of complaints on the arbitrary implementation of the circular by certain shipowners/operators" (MARINA Letter dated 13 October 1993 signed by Deputy Administrator Lamberto V. Pia);

WHEREAS, the suspended items Nos. (3) and (4) of MARINA MC No. 48 refer to the imposition of the 100% additional fare as penalty on unticketed passengers;

WHEREAS, Viva Shipping Lines (VSL) and Sto. Domingo Shipping Lines continue to impose said 100% penalty in the Batangas-Calapan route contrary to the decision of the MARINA Board;

NOW THEREFORE, be it resolved, as it is hereby resolved, to request MARINA to investigate and take appropriate action on the continued imposition by Viva Shipping Lines and Sto. Domingo Shipping Lines of the 100% penalty on unticketed passengers in the Batangas-Calapan route, contrary to the decision of the MARINA Board during its 67th Board Meeting on 27 September 1993 suspending the same.

Let copies of this resolution be immediately furnished the Office of the President, OOTC Secretary Jesus B. Garcia, and MARINA Administrator Facienda M. Balcon, Jr.
