RESOLUTION AUTHORIZING HONORABLE RODOLFO G. VALENCIA, PROVINCIAL GOVERNOR, ORIENTAL MINDORO TO ENTER INTO A CREDIT AGREEMENT BY EXTENDING A LOAN OF P2.5 MILLION TO ENGINEER ALFREDO M. ATIENZA FOR THE OPERATION OF MV ACE INTENDED TO PLY THE CALAPAN-BATANGAS BATANGAS-CALAPAN SEA ROUTE AND FOR THIS PURPOSE TO CONTRACT LOAN FOR THE SAME AMOUNT WITH LAND BANK OF THE PHILIPPINES

RESOLVED, as it is hereby resolved, to authorize, as it is hereby authorizing, the Provincial Governor to enter into a credit agreement by extending a loan of P2.5 Million to Engr. Alfredo M. Atienza at an interest rate of 3% per annum over and above whatever interest the credit or bank will impose on the Provincial Government and for this purpose to authorize the Provincial Governor to contract loan for the same amount with Land Bank of the Philippines.
