

MUNICIPAL ORDINANCE NO. 04

AN ORDINANCE EXTENDING THE DEADLINE FOR THE RENEWAL OF BUSINESS PERMITS IN ROXAS, ORIENTAL MINDORO FROM JANUARY 20, 2023 UNTIL FEBRUARY 07, 2023 WITHOUT PENALTIES TO ACCOMMODATE TAXPAYERS.

- WHEREAS, at the start of the year taxpayers and owners of business establishments in this municipality are congregating in droves at the Municipal Hall to either apply for new business permits or renew their old ones;
- WHEREAS, the second and third weeks of the month of January, all applications for renewal and new business permits were not fully accommodated that until January 20, which is the deadline for filing, there are still applicants lining at the Municipal Treasurer's Office based on experience from previous years;
- WHEREAS, on top of this the Municipal Treasurer's Office has still to complete the updating of all records for the E-TRACS (Enhanced Tax Revenue Assessment and Collection System);
- WHEREAS, with the following circumstances which are beyond the control of the taxpayers who failed to comply the requirements within the deadline, and sympathizing their plight, there is a need for this body to extend the deadline of the renewal of business permits to accommodate taxpayers without penalties;

WHEREAS, Section 167 of the Local Government Code states that, "unless otherwise provided in this Code, all local taxes, fees and charges shall be paid within the first twenty (20) days of January or of each subsequent quarter, as the case maybe. The Sanggunian concerned may, for justifiable reason or cause, extend the time of payment of such taxes, fees or charges without surcharges or penalties, but only for a period not exceeding six (6) months".

NOW THEREFORE BE IT ORDAINED by the Sangguniang Bayan in session assembled that:


SECTION 1. There is **EXTENDED** as the same is hereby **EXTENDED** until February 07, 2023, the deadline for the renewal of business taxes and fees, without penalties to accommodate taxpayers.

SECTION 2. EFFECTIVITY. This Ordinance shall take effect immediately.
